

## Double Vision DVD Cultural Contest

The Double Vision DVD cultural contest is sponsored by LANDSCAPE, EM&T, NIGmusic and NZaganin.

### Entries:

1- Download the playbacks on the promotion site [www.doublevisiondvd.com.br](http://www.doublevisiondvd.com.br) , record your video version and upload it on You Tube with the title: **Double Vision DVD Contest – song name - name of the performer**. IMPORTANT: There can be no errors in the title. The name of the performer can be abbreviated.

2 – After the video is publicly available on You Tube, send the video url to the email: [concurso@doublevisiondvd.com.br](mailto:concurso@doublevisiondvd.com.br) The email is your application. IMPORTANT: No contact with the contest direction is available. Please inform your phone number in the e-mail.

3 – Each contestant can record and upload as many songs as he/she wishes, provided the Backing Tracks on site [www.doublevisiondvd.com.br](http://www.doublevisiondvd.com.br) are used.

4 – Enter your full name, the name of the song being played and all personal information you may seem necessary into the video text. IMPORTANT: The search engine “Tags” must include the names: **Double Vision DVD Contest, Sydnei Carvalho and Alex Martinho**.

5 – The video and/or audio quality is not a factor for the selection. The performance, creativity, dynamics, phrasing and musicality of the contestant are key points for selection. An identical performance to the original recording is not a requirement.

6- The limit mailing term to enable entering the contest ends on August 31, 2010.

### **Selection:**

1- From all valid posts, 8 finalists will be chosen for a performance on September 20<sup>th</sup> at the Mix Music Hall of EM&T, school of music and technology of São Paulo, in the neighborhood of Jabaquara. Three finalists will then be selected by the judges in the order from first to third.

2 – Both the selection of the 8 finalists from all valid posts and the judgment of the final performance of the 3 first performers will be made by a panel of reputed guitarists and marketing professionals of the sponsor companies. The decision of this commission is final and irrevocable. No claim against the judgment will be accepted.

3 – All expenses and duties with transportation, meal, accommodation and any other expenses the finalist may have to travel to São Paulo and perform in the contest final show at ExpoMusic or at IGT/Guitar Player festival will be paid by the selected guitarist. In case he/she is not able to afford the expenses of his/her participation he/she will be replaced by another contestant.

4 – Contestants under the age of 18 years will obligatorily be accompanied by a parent or person whom will be legal responsible for the minor.

### **Announcement of finalists:**

4 – Employees of the sponsor companies - Landscape, NIG, EM&T and NZaganin - and any other people or companies involved in the organization of this cultural contest are ineligible to compete.

5 -All contestants waive their rights to the videos enrolled in the Double Vision DVD cultural contest for use by the production/direction of the contest as necessary to disclose the contest and the contestants.

6 – The mere participation in this cultural contest implies full knowledge and acceptance of these rules.

7 – Any divergences or situations not provided herein will be irrevocably and solely judged and decided by the judging commission.
